Riverside Area:

Take 60 Fwy EAST, Exit on CA-71 NORTH / GAREY. Turn Right on

GAREY. Turn another Right onto 71 NORTH. Turn Left on N. RANCH RD. Turn immediate Left on HUNTER POINT RD. Arrive at 59 HUNTER POINT RD, PHILLIPS RANCH. Home on the Right hand side.

Los Angeles Area:

Take the San Bernardino 10 Fwy East, go 24.6 mi. Take the CA-71 SOUTH Exit toward CORONA - go 2.8 miles. Exit and Make Right on N RANCH RD - go 0.1 mi. Turn immediate Left on HUNTER POINT RD. go 0.2 mi. Arrive at 59

HUNTER POINT RD, PHILLIPS RANCH. Home on your Right hand side.
